Please note the following guidelines regarding fees and charges:-

1. There is a onetime Registration fee of \$30 for the 1<sup>st</sup> child, \$15 for any siblings.
2. Clinics are charged via a simple monthly fee. Players are on a month to month commitment. Monthly Fees will be communicated upon signing up.
3. BG Tennis uses the secure services of the *Square Payment Processing* system. After receiving your Registration Form, you will be invoiced via email for the Registration Fee and first month's fee. You will pay this online and save your chosen card on the secure site of the Square Payment system.
4. Thereafter, you will be set up on the secure Square Payment system for the monthly fee. This will be charged to your card on the 1<sup>st</sup> day of each month.
5. Monthly fees will be pro-rated for any previous rain outs. No credits or refunds will be issued for absence, regardless of reason including: illness, vacation, or any other causes.
6. During breaks from school like Summer Break, Thanksgiving, Spring Break and Winter Break, clinics will be offered. Prior to the month commencing please communicate what days you will be away for.
7. For Monday players only - tennis will not take place on major holidays like Memorial Day and Labor Day and therefore fees will be pro-rated for these.
8. BG Tennis will follow either the Hillsborough County or Pasco County School calendar depending on where the program is located.
9. Notification of cancelled clinics will be done via the RainedOut system. You will be notified of how to register for this when you sign up.
10. Players wishing to cancel this arrangement should contact BG Tennis in writing by email at LiveoakTennis@yahoo.com. Please contact at least 15 days prior to the next billing date.
